- Artists will be assigned a business upon approval of work and receipt of payment, **on a first come basis**.
- Coordinate with the business and coordinator on a mutually agreeable date and time to install and remove artwork for your two-month show. (Indicate date/time **preferences** above)
- Upon installation, provide the business and Art Walk coordinator with an inventory of Art on exhibit.
- Be present at the businesses location for a Meet the Artist Reception, 5-8pm (June 7th or Aug 2nd).
- The Artist will leave sold art up throughout the show, and will handle all sales
- No commission will be paid on any sales of exhibited work.
- You will assume risk of loss or damage to your artwork; reasonable security will be provided during the entire display.
- You will agree to hold harmless and indemnify the venue and the City of Auburn, including its officers, agents, and employees, from and against all claims, demands, damages, or costs arising from property damage to the artwork and from any bodily injury connected with or arising from the display of such artwork.
